

Immunization Test Case IZ_7_1.1

Complete Record; 1 new immunization, 1 historial, and 1 new combo immunization

Test Story

Description

A toddler, Jirra Emmanuelle Mercer, is brought to the clinic on Aug 16, 2012 for a well child visit. The clinic staff collects basic identifying information, including name, birth date, and sex. A clinician reviews the patient's vaccination history and determines that the child previously received a IPV (ipol)vaccine on Feb 16, 2011. A clinician reviews the patient's vaccination history and determines that the patient needs an Influenza (Fluvirin)vaccination and a DTaP-Hib-IPV (Pentacel) combination vaccination. A clinician interviews the mother and determines that the patient qualifies for all Vaccines For Children (VFC) supplied vaccines under the status of VFC eligible - Federally Qualified Health Center Patient (under-insured). A clinician gives the mother four Vaccine Information Statements (VIS) to review: Inactivated Flu published Jul 02, 2012, DTaP published May 17, 2007 Hib published Nov 08, 2011, and Polio published Nov 8, 2011. After reading them the mother agrees that the child should receive all the vaccinations recommended. A clinician prepares an Influenza vaccination dose, GlaxoSmithKline Lot # K5094SC, from the VFC publicly supplied vaccine stock and administers it to the patient in the right arm. A clinician prepares a DTaP-Hib-IPV vaccination dose, sanofi pasteur Lot #568AHK11, from the VFC publicly supplied vaccine stock and administers it to the patient in the right arm. A clinician enters the patient demographic information, VFC status, VIS information, vaccination history, and vaccination administration information into the EHR and transmits it to the IIS.

Test Objectives

This test case examines the ability of an EHR to create a VXU message for a well child visit where a single, historical and combination vaccination will be reported. A typical populated message for this test case must provide; - Patient demographic information in the PID segment. - Vaccination administration information in the RXR and RXA segment; RXA.9 must be populated indicating if the record is based on a historical or a new immunization record. - In each RXA segment the report must provide additional information regarding the vaccination in the OBX segments; - For a single vaccination, the vaccine funding program eligibility category, VIS document type, date vaccine information statement was published and the date the information statement was presented must be provided. - For a historical vaccination, no additional information is necessary. - For a combination vaccination, the vaccine funding program eligibility category must be provided and for each vaccine in the VIS document type, the date vaccine information statement was published and the date the information statement was presented must be provided. The test case provides an example of the patient information, and vaccination administration information.
