# Health Equity is the attainment of the highest level of health for all people.

The term "equity" means the consistent and systematic fair, just, and impartial treatment of all individuals, including individuals who belong to underserved communities that have been denied such treatment.

#### This includes:

- Women and girls
- Black, Latino, and Indigenous and Native American persons
- Asian Americans and Pacific Islanders and other persons of color
- Persons facing discrimination or barriers on account of gender identity

- Members of religious minorities
- Lesbian, gay, bisexual, transgender, and queer (LGBTQ+) persons
- Persons with disabilities
- Persons who live in rural areas
- Persons otherwise adversely affected by persistent poverty or inequality.
