Great. Thank you, Lauren. Thanks everybody for joining this last call, and Terry and I both very much appreciate everybody's hard work on getting our recommendations together and

the letter done last week. So, thank you, thank you, thank you. Unfortunately, Terry's flight got delayed and he's on a plane to D.C. right now, but we decided to go ahead and have this meeting anyhow.

I know our recommendations are done, they're submitted, and we can't make any changes. However, because of the tight turnaround time and the fact that we had to make some changes that the task force wasn't able to discuss, we did want to just open the dialogue and point out some things and changes that we made, because while we might not be able to make any changes to the draft recommendations that were submitted to the HITAC, we can speak to any issues or concerns that the task force has when we present tomorrow.

So, with that said, some of the things that we added were a graphic for the definitions. So, I know there was a lot of discussion regarding the definitions and terms we used, and we ended up using, to describe a data class a hierarchy of a data class, starting with the data class, going to a data object and a data attribute. We did put a disclaimer in our letter that the task force did have extensive discussion regarding these definitions and terms, and that they are really meant to offer clarity to our recommendations and there were several alternatives. So, we are not trying to make the definitions actually recommendations, just more of a way to guide a reader through the recommendations that we did make. So, that was our way of addressing a lot of the concerns that the task force had there.

And then in each stage, we added a paragraph at the end. So, in stages one through six for our actual process, we added a small paragraph with issues to be clarified during our pilot testing. So, one of the things that was brought up in our last call was the need for more pilot testing. So, at the beginning of the recommendations in the overview, we put that the full process should actually be tested prior to implementation.

And then we added one more area, which had to do with the TEFCA in our additional recommendations. So, it was to test the USCDI process by addressing critical Trusted Exchange Framework requirements. While the task force agreed that piloting was extremely important and alignment with the TEFCA was extremely important, we hadn't merged those concepts. So, that was another area that we wanted to draw attention to that was added. And again, this is our additional recommendation.

So, with that, I will kind of stop and let people process what we said. And we can definitely bring up in discussion any areas or concerns that the task force does have.

Christina, this is Lauren. So, just to be clear, are you referring to the section in the document under the Additional Recommendations? Or did you want to point out specific text within the document?

Yeah, and I don't know if we have slides up. I kind of wanted to give a general overview. And I know that was very high level and we didn't have an actual presentation to go along with this

call, but we got some feedback that this was a quick turnaround from the task force to review the recommendations letter, so we just wanted to make sure that we gave everybody the opportunity to add any other comments. I'm happy to — we can either pull up the slide — I don't know if it's available — or I can read through what that recommendation was that I just referenced to the Trusted Exchange Framework and testing the USCDI process.
