## Health Information Technology Advisory Committee Information Blocking Task Force Workgroup 1: Relevant Statutory Terms and Provisions April 03, 2019, 12:00 p.m. – 2:00 p.m. ET Virtual

The April 03, 2019, meeting of the Information Blocking Task Force Workgroup 1: Relevant Statutory Terms and Provisions of the Health IT Advisory Committee (HITAC) was called to order at 12:00 p.m. ET by Lauren Richie, Designated Federal Officer, Office of the National Coordinator for Health IT (ONC).

Lauren Richie called the meeting to order and conducted roll call.

Lauren Richie turned the meeting over to Michael Adcock, co-chair.

**Michael Adcock** reviewed the agenda. There was a lot of discussion about the agenda, but the group agreed to move forward with the planned agenda and discuss price transparency during the next meeting.

## Health information networks/exchanges

**Andy Truscott** reviewed the language that was in 21<sup>st</sup> Century Cures (Cures). He proposed the following language.

*Health Information Exchange* or *HIE* means the act of accessing, transmitting, processing, handling, or other such use of Electronic Health Information, or the organization or entity conducting that act.

Health Information Network or HIN means an individual or entity that satisfies one or several of the following—

- (1) Determines, oversees, administers, controls, or substantially influences policies or agreements that define business, operational, technical, or the conditions or requirements for Health Information Exchange between or among two or more unaffiliated individuals or entities, or
- (2) Provides, manages, or controls, or substantially influences any technology or service that enables or facilitates health Information Exchange between or among two or more unaffiliated individuals or entities, or

(3) Determines, oversee, administers, controls, or substantially influences policies or agreements that define business, operational, technical, or other conditions or requirements for Health Information Exchange between or among two or more affiliated individuals or entities, or

(4) Provides, manages, controls, or substantially influences any technology or service that enables or facilitates Health Information Exchange between or among two or more affiliated individuals or entities.

**Cynthia Fisher** thought ONC did a good job of merging the Cures definition which was already discussed. . Cynthia expressed concerns about vertically integrated organizations.

Sheryl Turney has concerns over inclusion of affiliated individuals and entities in HIN definition.

**John Kansky** summarized a potentially impactful discussion point. He noted that it is important that there isn't a definition of developer that is limited to certified technology. There are developers that may not certify their technology, such as those developed for IOS or EHRs that are given away. The regulation could amplify the business opportunity of not sharing data.

- Mark Knee noted that there could potentially be a statutory amendment.
- Sheryl Turney suggested requiring that a system that uses PHI has to be certified.
- The group disagreed with this because there isn't a certification for these programs (e.g., HIE).

Andy Truscott agreed to share a comparison document that will show the changes that have been made.

The definition below is where the group landed at the end of the call and is reviewing to come to a consensus.

*Health Information Exchange* or *HIE* means the act of accessing, transmitting, processing, handling, or other such use of Electronic Health Information, or the organization or entity conducting that act.

Health Information Network or HIN means an individual or entity that satisfies one or several of the following—
