**Overarching charge**: Review and provide recommendations on the Draft USCDI Version 3 and other interoperability standards

2	Identify opportunities to update the ONC Interoperability Standards Advisory (ISA) to address the HITAC priority uses of health IT, including related standards and implementation specifications.	June 16, 2022



## **HITAC Priority Uses of Health IT**

 In general, the HITAC shall make recommendations to the National Coordinator for Health Information Technology on a policy framework for adoption by the Secretary consistent with the strategic plan under section 3001(c)(3) of the PHSA, as amended for advancing the following target areas:



Use of Technologies that Support Public Health: The facilitation of bidirectional information sharing between the clinical and public health communities



**Privacy and Security:** The promotion and protection of privacy and security of health information in health IT



### Interoperability:

Achieving a health information technology infrastructure that allows for the electronic access, exchange, and use of health information



#### Patient Access: The facilitation of secure

access by an individual and their caregiver(s) to such individual's protected health information
